LONDON: The British government has agreed to offer millions of public sector workers pay raises in a bid to end an array of strikes, including a five-day walkout from doctors in the early part of their career in Britain's publicly funded health service.

Prime Minister Rishi Sunak confirmed Thursday that the government was accepting the recommendations from pay review bodies, that will see police get a 7% rise, 6.5% for teachers and 6% for the junior doctors, who commenced their strike early Thursday.

So-called junior doctors, those who are at the early stages of their careers in the National Health Service in the years after medical school, started their latest strike at 7 am, with many of them making their case for a 35% pay rise in picket lines outside hospitals across England.

The British Medical Association, the doctors' union, has asked for a 35% pay rise to bring junior doctors' pay back to 2008 levels once inflation is taken into account. Meanwhile, the workload of England's 75,000 or so junior doctors has swelled as patient waiting lists for treatment are at record highs in the wake of the coronavirus pandemic. "Today marks the start of the longest single walkout by doctors in the NHS's history, but this is still not a record that needs to go into the history books," said BMA leaders.

The first 37 bodies were buried on June 20, the UN agency said in a statement from Geneva. The next day, another 50 bodies were dumped at the same site. Seven women and seven children were among those buried.

Support Forces erupted into open fighting. Darfur has been at the epicentre of the 12-week conflict, morphing into ethnic violence with RSF troops and allied Arab militias attacking African ethnic groups.

The RSF and allied Arab militias rampaged through the western region, forcing hundreds of thousands to flee their homes, rights groups say.

Just over 238,000 people have crossed the border from Darfur into neighboring Chad,

according to recent figures from the International Organisation for Migration. Amid the pillaging, entire towns and villages in the province of West Darfur have been burned to the ground and looted.

News of the mass grave comes just days after Human Rights Watch called for the International Criminal Court to investigate atrocities in Darfur. In highlighting its call, it pointed to the "summary executions" of at least 28 Masalit tribesmen at the hands of RSF and allied Arab militias in the town of Misterei, also in West Darfur province.

The New York-based rights group said that several thousand members of the paramilitary Rapid Support Forces and their allies rampaged through Misterei on May 28 armed with assault rifles, rocket-propelled grenades and machine guns, before slaughtering its Masalit male inhabitants.

The Screen Actors Guild American Federation of Television and Radio Artists (SAG-AFTRA) had set a deadline for 11:59 pm Wednesday mere hours after this year's Emmy nominations were announced for a deal to be reached. Just after midnight Thursday, no update had been announced.

If the actors strike, they will formally join screenwriters on the picket lines outside studios and filming locations in a bid to get better terms from studios and streaming giants like Netflix and Amazon. It would be the first time since 1960 that the two guilds are on strike at the same time.
