

Sanghvi's advice on good behavior with citizens did not last 24 hours

Ahmedabad, Last week, an incident of police personnel beating up a motorist came to light in Ahmedabad city. After this, another incident has come to light, in which a police officer slapped a woman after she dropped her police ID card. The woman was slapped to such an extent that blood started coming out of her eye. When the woman reached Paldi police station to complain about this, the PSI and PIA of Paldi police station threatened the woman and refused to take the complaint, but the woman sat in the police station till late at night and filed an application.

In another incident, a condemnable case of police misconduct has come to light from Home Minister Harsh Sanghvi's city of Surat. This entire misconduct of a constable of Umra police station has been captured in the CCTV camera installed in the shop. The video clearly shows that instead of giving a legal explanation to the trader or taking legal action for keeping the shop open late at night, the constable directly raises his hand on the trader.

In this incident seen in the CCTV footage, the constable slaps the shopkeeper hard and then beats up another person present there and pushes him. Although the shopkeeper had broken the rules and kept the shop open till late at night, the fact that the police instead of enforcing the law resorted to beating him up raises serious questions. After this incident, there is a lot of anger among the local traders, when Bhaskar tried to talk to the victim trader, although the victim trader has

not yet come forward officially due to fear.

On December 18, 2025, at the inauguration program of Khakhi Bhavan in Ahmedabad, Gujarat Home Minister Harsh Sanghvi advised the Ahmedabad Police that policing should be done in such a way that the feet of criminals should tremble. The advice to the Ahmedabad Rural Police is that it is not surprising that the behavior of criminals should change. Traffic police personnel got agitated when Bansariben requested her to stand aside.

Bansariben submitted a written application to the police station at 11:50 pm. Regarding this, PI M.N. Parevda of Paldi Police Station said that since the issue was traffic related, they asked to file a complaint at the traffic police station and the cross-complaint was asked because there was a clash both times, so there was a situation where there was a face-to-face complaint.

People had to travel without tickets

Ticketing staff missing at 4 BRTS bus stands, agency only fined

It has come to light that there is an absence of staff at the public transport service BRTS bus stands in Ahmedabad. It has come to light that the staff hired to issue tickets were not present at the city's Astodia Darwaja, Astodia Chakla, Kalupur and Juna Vadaj bus stands after the afternoon of December 17. A passenger had filmed a video of the staff being absent near Astodia Darwaja and went viral on social media and a complaint was filed with BRTS, following which it was revealed that there was no staff at the other three bus stands as well, and only a general fine has been taken against the contractor agency Sameer.M.Shah.

When asked the security

staff, they said that no ticket staff was present after noon.

Lakhs of passengers travel in BRTS buses every day. The corporation also generates an income from the buses, but the negligence of the ticketing staff agency hired to give tickets to passengers at the bus stand has come to light. Yesterday, on December 17, a video was uploaded by an alert passenger on social media and went viral. In which no ticketing staff was present at the Astodia Darwaja bus stand. The passengers who were coming to the bus stand went to the ticket window to get tickets, but no one was present there. When asked the security staff present at the bus stand, they said that no ticket staff was present after noon. 4. Staff was not present at the bus stand after

noon.

This video went viral on social media and later the passenger also complained to the BRTS administration. Following which, an investigation was conducted by the administration and it was noticed that no staff came to the BRTS bus stands at Astodia Darwaja, Astodia Chakla, Kalupur and Juna Vadaj after noon. The administration was satisfied by imposing a fine of only Rs 1 lakh on the contractor, following which the contractor agency Sameer.M.Shah was immediately informed. Even though it is the agency's responsibility to deploy ticketing staff, they have not deployed staff, following which the administration has now taken action against them. However, the administration will be satisfied by imposing a fine of only Rs 1 lakh. Ticketing scams have also come to light in the past. Such cases have come to light frequently at the BRTS bus stand. Ticketing scams have also come to light in the past. There was also an incident of cheating people by giving old tickets. The contractor agency Sameer.M.Shah did not put ticketing staff at the bus stand and the corporation has been damaged, but the officials of the BRTS system are content with only imposing a simple fine on such contractor agencies. Astodia Darwaja, Kalupur and Vadaj are very crowded and many passengers travel daily, so people were forced to travel without tickets.

Ahmedabad sees surge in childhood cancer as HOC Vedanta reports 200 paediatric cases in six months

Ahmedabad, The tertiary care oncology facility HOC Vedanta Ahmedabad, has treated approximately 200 paediatric cancer patients over the past six months, with blood cancers, particularly Leukaemia, emerging as the predominant diagnosis. Dr. Deepa H Trivedi (Pediatric Hemato-Oncologist), HOC Vedanta Ahmedabad, said, "We are witnessing a steady influx of paediatric patients, with leukaemia trending as the most common diagnosis. Early detection and timely treatment are vital. Given that childhood cancers, though

rare are often treatable, our focus is on raising awareness among parents, strengthening referral networks, and ensuring uninterrupted access to care." According to hospital records, nearly 45–50% of all paediatric cases admitted during this period were identified as leukaemia, consistent with broader local trends. At the state-level centre Gujarat Cancer and Research Institute (GCRI), leukaemia, both lymphoid and myeloid accounted for 44.9% of childhood cancer diagnoses in 2022. (13-9)

J&K: Anti-sabotage operation carried out in Srinagar

Srinagar, Security forces on Tuesday carried out anti-sabotage operations around vital installations in J&K's Srinagar city. An official said that operations were carried out with the aim of strengthening security measures and countering any potential threats.

He said that police had carried out anti-sabotage operations in Maharaja Bazaar and Amira Kadal areas in the vicinity of Bakshi Stadium, which is the main venue for Republic Day and Independence Day celebrations in the Valley.

"It is routine for the security forces to carry out special drills and operations before the country's Republic Day and the Independence Day to ensure that the terrorists are prevented from disrupting various flag hoisting ceremonies, parades and cultural events held on these national celebration days," the official said. He said that area security and anti-sabotage (AST) operations were carried out by police and the Central Reserve Police Force (CRPF) in close coordination around major vital installations and sensitive locations in the North Zone of Srinagar, to strengthen preventive security

measures and counter any potential threats. The official said that the purpose of the joint security exercise is to reinforce the overall security grid, enhance operational preparedness, and ensure the safety and security of critical infrastructure as well as the general public.

"During the operation, thorough checking and sanitisation of the identified areas were carried out, along with a comprehensive review of existing security arrangements," he said.

The official said that similar security drills have been conducted in some areas of Anantnag district.

In contrast to the past, when flag hoisting, ceremonial parades, etc, remained a strictly official event, after 2019, when Article 370 was removed and J&K brought under direct central control, people in large numbers now participate in official functions on Republic Day and Independence Day.
