The ethnic unrest in Manipur began on May 3 following a protest by the Kuki tribes against the Meiteis' demand for inclusion under the Scheduled Tribes (ST) category. Though the immediate cause of the ethnic clashes is said to be over the Meiteis' demand for ST tag, many leaders, including Home Minister Amit Shah and Foreign Minister S Jaishankar, have said entry of illegal immigrants is one of the main factors behind the unrest in the northeast state. The NIA has said it is looking into an alleged transnational conspiracy involving terror groups hiding in Bangladesh, Myanmar and Manipur to exploit the ethnic violence in the northeast state.

As in a state or a Union Territory, we will set up a self-government that will look into all matters in the Kuki-Zo areas. We have to do this since our voice has not been heard," Mr Tombing said. Ten tribal MLAs, including those from the ruling BJP, have demanded a total separation from Manipur. They have said the state is dominated by the valley-
